- (1) that the Bid Security shall remain in force up to and including the date 28 days after the deadline for validity of bids as stated in the Instructions to Bidders or as it may be extended by the Employer, notice of which extension(s) to the Surety is hereby waived;
- (2) that the Bid Security of unsuccessful Bidders will be returned by the Employer after expiry of its validity or upon signing of the Contract Agreement; and
- (3) that in the event of failure of the successful Bidder to execute the proposed Contract Agreement for such work and furnish the required Performance Security, the entire said sum be paid immediately to the said Employer pursuant to Clause 15.6 of the Instruction to Bidders for the successful Bidder's failure to perform.

THIS CONTRACT AGREEMENT (hereinafter called the "Agreement") made on the day of between Member (Central Zone) , National Highway Authority, Shahpur Interchange, Thokar Niaz Baig, Multan Road, Lahore. (Hereinafter called the "Employer" which expression shall include the successors, legal representatives and permitted assignees) of the one part and (hereinafter called the "Contractor") of the other part.

The following documents after incorporating addenda, if any, except those parts relating to Instructions to Bidders shall be deemed to form and be read and construed as part of this Agreement, viz: a) The Contract Agreement; b. The Letter of Acceptance; c. The completed Form of Bid; d. Addendum/Corrigendum to Bid (if any); e. Special Stipulations (Appendix-A to Bid); f. The Particular Conditions of Contract – Part II; g. The General Conditions – Part I; h. The priced Bill of Quantities (Appendix-D to Bid); i. The completed Appendices to Bid (B, C, E to L); j. Special Provisions; k. Supplementary Specifications; I. Particular Specifications; m. The Drawings; n. NHA General Specifications and its addendum; o. Performance Security
In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy defects therein in conformity and in all respects with the provisions of the Contract.


